

COMPLAINT INFORMATION FORM

It is against the law for CareerSource Citrus Levy Marion as a recipient of financial assistance under Title I of the Workforce Innovation and Opportunity Act (WIOA), to discriminate on the basis of race, color, marital status, religion, sex, national origin, age, disability, veteran status, political affiliation or belief. It is also against the law for CareerSource Citrus Levy Marion to discriminate against any beneficiary of Federally financially assisted programs on the basis of the beneficiary's citizenship/ status as a lawfully admitted immigrant authorized to work in the United States, or his or her participation in any WIOA Title I financially assisted program or activity. CareerSource Citrus Levy Marion prohibits such unlawful discrimination as deciding who will be admitted, or have access, to any WIOA Title I-funded program or activity; providing opportunities in, or treating any person with regard to, such a program or activity; or making employment decisions in the administration of, or in connection with, such a program or activity. If you feel you have been adversely affected by a decision or action made by CareerSource personnel and have discussed the matter with the Center Manager, you have the right to file a written grievance/complaint to CareerSource Citrus Levy Marion's Equal Opportunity Officer - Contact Information: Iris Pozo, EOO, CareerSource Citrus Levy Marion, 3003 SW College Road Suite 205, Ocala, FL 34474, (352) 873-7939 -- or directly to the Department of Economic Opportunity. Information on filing a grievance/complaint can be obtained from the CareerSource Citrus Levy Marion's Equal Opportunity Officer. After the opportunity for a hearing (within 60 days after formal filing), if you are dissatisfied, you may appeal to the Department of Economic Opportunity, Office of Civil Rights, 107 East Madison Street- MSC 150, Tallahassee, FL 32399.

If you think that you have, or someone else has, been subjected to discrimination by CareerSource Citrus Levy Marion on one of the basis listed above, you may file a complaint within 180 days from the date of the alleged violation with either the CareerSource Citrus Levy Marion or the U.S. Department of Labor's Civil Rights Center (CRC). If you have missed this deadline and think you have good cause for filing late, you must explain the circumstances and request an extension from the Director of CRC at the address listed below. The Director will determine whether you have proven good cause for an extension and notify you of his/her determination. You may also contact the Local EO Officer for other complaint investigative authorities and their reporting deadlines.

To file a complaint, you may use this Complaint Information Form, or send the information listed on this form, in writing, either to CareerSource Citrus Levy Marion, DEO or USDOL.
